An Internet Protocol address (IP address) is a numerical label such as 192.0.2.1 that is assigned to a device connected to a computer network that uses the Internet Protocol for communication. IP addresses serve two main functions: network interface identification, and location addressing.

Internet Protocol version 4 (IPv4) was the first standalone specification for the IP address, and has been in use since 1983. IPv4 addresses are defined as a 32-bit number, which became too small to provide enough addresses as the internet grew, leading to IPv4 address exhaustion over the 2010s. Its designated successor, IPv6, uses 128 bits for the IP address, giving it a larger address space. Although IPv6 deployment has been ongoing since the mid-2000s, both IPv4 and IPv6 are still used side-by-side as of 2025.

IP addresses are usually displayed in a human-readable notation, but systems may use them in various different computer number formats. CIDR notation can also be used to designate how much of the address should be treated as a routing prefix. For example, 192.0.2.1/24 indicates that 24 significant bits of the address are the prefix, with the remaining 8 bits used for host addressing. This is equivalent to the historically used subnet mask (in this case, 255.255.255.0).

The IP address space is managed globally by the Internet Assigned Numbers Authority (IANA) and the five regional Internet registries (RIRs). IANA assigns blocks of IP addresses to the RIRs, which are responsible for distributing them to local Internet registries in their region such as internet service providers (ISPs) and large institutions. Some addresses are reserved for private networks and are not globally unique.

Within a network, the network administrator assigns an IP address to each device. Such assignments may be on a static (fixed or permanent) or dynamic basis, depending on network practices and software features. Some jurisdictions consider IP addresses to be personal data.

The Internet protocol suite, commonly known as TCP/IP, is a framework for organizing the communication protocols used in the Internet and similar computer

The foundational protocols in the suite are the Transmission Control Protocol (TCP), the User Datagram Protocol (UDP), and the Internet Protocol (IP). Early versions of this networking model were known as the Department of Defense (DoD) Internet Architecture Model because the research and development were funded by the Defense Advanced Research Projects Agency (DARPA) of the United States Department of Defense.

The Internet protocol suite provides end-to-end data communication specifying how data should be packetized, addressed, transmitted, routed, and received. This functionality is organized into four abstraction layers, which classify all related protocols according to each protocol's scope of networking. An implementation of the layers for a particular application forms a protocol stack. From lowest to highest, the layers are the link layer, containing communication methods for data that remains within a single network segment (link); the internet layer, providing internetworking between independent networks; the transport layer, handling host-to-host communication; and the application layer, providing process-to-process data exchange for applications.

The technical standards underlying the Internet protocol suite and its constituent protocols are maintained by the Internet Engineering Task Force (IETF). The Internet protocol suite predates the OSI model, a more comprehensive reference framework for general networking systems.

Network address translation (NAT) is a method of mapping an IP address space into another by modifying network address information in the IP header of packets while they are in transit across a traffic routing device. The technique was initially used to bypass the need to assign a new address to every host when a network was moved, or when the upstream Internet service provider was replaced but could not route the network's address space. It is a popular and essential tool in conserving global address space in the face of IPv4 address exhaustion. One Internet-routable IP address of a NAT gateway can be used for an entire private network.

As network address translation modifies the IP address information in packets, NAT implementations may vary in their specific behavior in various addressing cases and their effect on network traffic. Vendors of equipment containing NAT implementations do not commonly document the specifics of NAT behavior.

The modern concept of intellectual

property developed in England in the 17th and 18th centuries. The term "intellectual property" began to be used in the 19th century, though it was not until the late 20th century that intellectual property became commonplace in most of the world's legal systems.

Supporters of intellectual property laws often describe their main purpose as encouraging the creation of a wide variety of intellectual goods. To achieve this, the law gives people and businesses property rights to certain information and intellectual goods they create, usually for a limited period of time. Supporters argue that because IP laws allow people to protect their original ideas and prevent unauthorized copying, creators derive greater individual economic benefit from the information and intellectual goods they create, and thus have more economic incentives to create them in the first place. Advocates of IP believe that these economic incentives and legal protections stimulate innovation and contribute to technological progress of certain kinds.

The intangible nature of intellectual property presents difficulties when compared with traditional property like land or goods. Unlike traditional property, intellectual property is "indivisible", since an unlimited number of people can in theory "consume" an intellectual good without its being depleted. Additionally, investments in intellectual goods suffer from appropriation problems: Landowners can surround their land with a robust fence and hire armed guards to protect it, but producers of information or literature can usually do little to stop their first buyer from replicating it and selling it at a lower price. Balancing rights so that they are strong enough to encourage the creation of intellectual goods but not so strong that they prevent the goods' wide use is the primary focus of modern intellectual property law.

Internet Protocol

The Internet Protocol (IP) is the network layer communications protocol in the Internet protocol suite for relaying datagrams across network boundaries

The Internet Protocol (IP) is the network layer communications protocol in the Internet protocol suite for relaying datagrams across network boundaries. Its routing function enables internetworking, and essentially establishes the Internet.

IP has the task of delivering packets from the source host to the destination host solely based on the IP addresses in the packet headers. For this purpose, IP defines packet structures that encapsulate the data to be delivered. It also defines addressing methods that are used to label the datagram with source and destination information.

IP was the connectionless datagram service in the original Transmission Control Program introduced by Vint Cerf and Bob Kahn in 1974, which was complemented by a connection-oriented service that became the basis for the Transmission Control Protocol (TCP). The Internet protocol suite is therefore often referred to as TCP/IP.

The first major version of IP, Internet Protocol version 4 (IPv4), is the dominant protocol of the Internet. Its successor is Internet Protocol version 6 (IPv6), which has been in increasing deployment on the public Internet since around 2006.

To encapsulate an IP packet in another IP packet, an outer header is added with Source IP, the entry point of the tunnel, and Destination IP, the exit point of the tunnel. While doing this, the inner packet is unmodified (except the TTL field, which is decremented). The Don't Fragment and the Type Of Service fields should be copied to the

outer packet. If the packet size, including the outer header, is greater than the Path MTU, the encapsulator fragments the packet. The decapsulator will reassemble the packet.

IP code

The IP code or Ingress Protection code indicates how well a device is protected against water and dust. It is defined by the International Electrotechnical

The IP code or Ingress Protection code indicates how well a device is protected against water and dust. It is defined by the International Electrotechnical Commission (IEC) under the international standard IEC 60529 which classifies and provides a guideline to the degree of protection provided by mechanical casings and electrical enclosures against intrusion, dust, accidental contact, and water. It is published in the European Union by the European Committee for Electrotechnical Standardization (CENELEC) as EN 60529.

The standard aims to provide users more detailed information than vague marketing terms such as waterproof. For example, a cellular phone rated at IP67 is "dust resistant" and can be "immersed in 1 meter of freshwater for up to 30 minutes". Similarly, an electrical socket rated IP22 is protected against insertion of fingers and will not become unsafe during a specified test in which it is exposed to vertically or nearly vertically dripping water. IP22 or IP2X are typical minimum requirements for the design of electrical accessories for indoor use.

The digits indicate conformity with the conditions summarized in the tables below. The digit 0 is used where no protection is provided. The digit is replaced with the letter X when insufficient data has been gathered to assign a protection level. The device can become less capable; however, it cannot become unsafe.

There are no hyphens in a standard IP code. IPX-8 (for example) is thus an invalid IP code.
